- Coordinated **triage** admissions with teams, aligning bed placement, observation needs, medications, and handoffs.

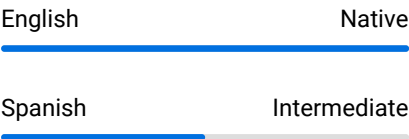
